Diplomacy Training Program

Teaching Program Jan 6 - 31, 1992

The Teaching Program features lectures, with discussion; workshops and role play; journal writing time; and Country Reports.

Workshops are defined as a learning process where the participants are actively involved in groups. There are two different types of group used - country groups (where participants join together through their country of origin) and ordinary groups (allocated at the beginning of week 1 and then reallocated at the beginning of week 3).

There is a considerable amount of individual work as well. A Journal will be kept by all participants (in their own language). This will enable them to set their own objectives, make the session personal for them alone, and structure their note taking. Some journal sessions involve structured question sheets. The Journal Summary will be written in English and will be used as part of the assessment process.

Although the session uses UN models in most of its examples, and in role play workshops, the skills learned are applicable to other forums and committees, whether they be national, regional or international.

Skills development in report writing, oral presentation, negotiation and lobbying, listening and participating in group work are specifically addressed throughout this session.

All participants will be involved in presenting a Country Report, describing their own country and their organisation's work.

All participants will finish the session with a personal Action Plan, arising from their own identification of their needs and objectives.

The Certificate of Satisfactory Completion will be awarded to qualifying participants, assessed on the following basis: a multiple choice test, written and oral work, and each participant's Journal Summary; Attendance (90% of all class time).

All participants will receive a DTP Certificate of Attendance and a group photograph.
