Nicholas Stewart, Vice President Australian Lawyers for Human Rights



Nicholas Stewart is the Vice Present of Australian Lawyers for Human Rights and a partner at the Dowson Turco Lawyers. He is the recipient of the NSW Law Society President's Medal (2022), Friend of Distinction at the University of Technology Sydney, Vice President of New Theatre Properties, Member of the Diversity & Inclusion Committee of the Law Society of NSW and Chair of the Women's Advancement Subcommittee. Nicholas is a published writer and keynote speaker. He has spent four years campaigning for an inquiry into one of NSW's darkest chapters: the gay-hate crimes and bungled police investigations that plagued the state from 1970 to 2000. In that time, more than 80 gay men and transgender people are thought to have been murdered and a large number of those cases remain unsolved. A Special NSW Commission of Inquiry into historical LGBTIQ deaths was announced in April 2022 and is currently in the process of hearing witnesses.

Lynda joined the Australian Labor Party at the age of 15. Her grandfather, boilermaker Ben Walsh, was a founder of the Birrong Branch of the Labor Party. From 1984 to 1987 Lynda was a member of the Australian Army Reserve and between 1987 and 1993, Lynda served in the Australian Regular Army and was in the second group of women to train at Kapooka in NSW. After leaving the army, she worked as a political staffer and an electoral officer.

Jasmina's involvement in the refugee field dates back to 1991. Joining STARTTS in the position of Counsellor/Project Officer supporting communities of former Yugoslavia in 1994, Jasmina remained in the position until 1999 when she took on the role of a Team Leader at Singleton Safe Haven. She has been in her current role of Community Services Coordinator since 2000 and manages over 60 staff.

Jasmina has an extensive knowledge and connections across many refugee communities including Armenian, Assyrian, Bosnian, Burundian, Chaldean, Congolese, East Timorese, Hazara and other Afghans, Karen, Kosovar, Liberian, Mandaean, Rohingya, Rwandan, Sierra Leonean, South Sudanese, Tamil, Tibetan, Uyghur, and Yazidi, and has worked with them for the last 20 years.

She also organised three CiCT Forums, four leadership courses for community leaders and a formal Uyghur community consultation in the last three years.
