Statement

I am Karath Mal Waka, I am the chairman of Human Rights Inter-Pacific (HRIPA) Inc based in Porgera. I am well pleased to take this golden opportunity offered by tireless working people of CIMC, sponsors; national government, UNDP Program, EU Program, Exon Mobil and others specifically, distinguished guest, The Rt Hon Prime Minister James Marape, Senior government officials from National Planning Department and Department of Treasury, other government bearcats, refs from civil societies, NGO Refs, churches, youth and others who are here.

I am a survivor of lawless in the upper highlands specifically Laiagam in the Western Part of Enga Province, let me take off my coat that covers my disability for ages. My mother did not give me birth like as you can me see now. I lost both of my right hands above elbow and I lost my right limb below my knee cap in which I am an amputee. I had lived with disability for more than thirty (30) years.

What you see is a subsequent of lawlessness in the upper highlands. Hundreds of guns are in civilians' hands. Murders are running freely taking impunity, rapist is running freely, killing and rapping is becoming a normal practise. Man, women and young girls including little children are becoming vulnerable in both urban centres and rural areas.

This is all because of because of the build-up of firearms in the upper highlands. It is a challenge that is here making our lives vulnerable to war lords or those who are in position of illegal firearms.

The rest come to my memory that it opened up canvas for me to testify here before the CIMC panel and everyone of you that I was in my teenage in 1995, I was confronted by couple of gunmen who shot me down and they chopped me mercilessly. I am an innocent student attending Grade Seven (Gr7) in Laiagam High School that time. I am a survivor of a domestic violence.

This thing happens to many people, thousands of our men and young boys are dying every day as we are speaking. Millions of our houses and properties including government funded infrastructures like schools and hospitals are going into ashes leaving our people suffer in our God given land.

We have hundreds of widows and orphans in every village in both the eastern and western part of Enga Province. This also is happening to other provinces like Western Highlands, Southern Highlands and Hela Province.

Why is our government allowing those outlaws and criminals run freely, our government should arrest them and give them capital punishment.

I have a statement in support of Lady Martilda who spoke to you the Rt Hon Prime Minister to purchase a satellite for Papua New Guinean citizens to run freely under satellite cameras giving CCTV Image coverage of all movements. We need security cameras installed everywhere in both rural and urban centres.

The satellite will help us in many ways like fast and efficient form of free communications, it's about time this Marape Roso Government must purchase a satellite and capture those outlaws and give them capital punishment.

We as a nation of more than one thousand tribes, blessed with more than 700 hundred languages. We have five (5) more months before we celebrate our 50 years of independence yet we are still struggling to live freely and enjoy the fullness of our wealth from our mineral recourses, both renewable and unrenewable energies. We want to enjoy life in our beautiful country of Papua New Guinea. Highlands and Upper Highlands, people living in our coastal areas, Manus, New Island and Bougainville. We want our government to enact tougher laws, give more powers to ICCAC, Ombudsmen Commission ITIPNG and reform the justice sector.

Slow Phase In Social Infrastructure Development

I as the chairman for HRIPA Inc is in support of West Enga United Front Association (WEUFA) Inc who steps into split unique Enga Province on the following reason for a robust economy that is sound and attractive in line with the United Nation's Vision 2050 and it's Seventeen (17) Sustainable Development Goal Programs as well as in line with PNG Government's Medium Term Development Goal (MTDG) Plan featured with the Twelve (12) MTDG Plans.

HRIPA supports WEUFA Inc informs with due respect expressing the inner most part of the Enga Provincial Administration. Action Governor Grand Chief Sir Peter Ipatas and his EPG administration hence his supporters must understand and distinguish the importance of splitting the Enga Province. The truth hurts whilst significantly the truth HRIPA & WEUFA Inc expressed yet it's very important to split Enga Province. The grand Chief must be in his greatest wisdom and comprehend the important values of splitting the Enga Province despite it hurts. HRIPA & WEUFA Inc inform that truth hurts, your weakness is our strength and the outcome of GCSPI's decision values the province split sets up a greatest milestone achievement in his (GCSPI) term as the governor of Enga Province reign with dignity and respect despite our critics that we put up as our foundation for split.

HRIPA &WEUFA Inc criticize that the western part of Enga Province suffered a slow phase in the development agenda in comparison with the eastern part of Enga Province and the rest of Papua New Guinea. Since the Ipatas administration took over the Enga Provincial Administration in 1997,

the western part of Enga Province faced the worst manmade disasters in terms of trouble conflicts that destroyed the infrastructures of the western part of the Enga Province.

The Enga Provincial Government may give reason that the slowness of economic growth in the western part of Enga Province is due to continua's trouble fights however WEUFA Inc strongly condemns this at the strongest possible term. WEUFA Inc condemns that for if the Enga Provincial Government established a stronger government policies and created frameworks mechanism would have prevented those trouble fights.

HRIPA &WEUFA Inc holds' no apology with EPG neither anyone. HRIPA & WEUFA Inc now taking the ownership in bid for a province split after 50 years of Independence. WEUFA Inc is the reputable and none profitable human rights organization registered under the Investment Promotive Authority (IPA) act of Papua New Guinea vested on section 42-45 of the association act of Papua New Guinea to represent the voice of the entire people living in the western Part of Enga Province and specifically WEUFA Inc represents the voice of the people living in Laiagam-Lagaip District, Kandep District, Maip Mulitaka District, Maramuni District, parts of Ambum District and Porgera Hewa Paiyala District.

WEUFA Inc represents the voice of more than Three Hundred Thousand (300,000+) plus population living in the Western Part of Enga Province calling on the Enga Province split on the following reasons;

- 1. Lawlessness
- 2. Population
- 3. Land mass
- 4. Inadequate Social Infrastructure Development
- 5. Systematic Corruption & Political Freedom
- 6. Transit Plan
- 7. Terms of References & Agreement
- 8. Opene Provincial Government Proposal

1. Lawlessness

HRIPA & WEUFA Inc sincerely apologize the Rt Hon Governor Grand Chief Sir Peter Ipatas (GCSPI) and his supporters that our expression may offend you all besides we hold no apology. This is the clash of civilization due to population increase and it is at the highest need and demand for social infrastructure development. The truth hurts so we are putting up the truth for GCSPI and his supporters to read their own failures and simply split the province as East and West.

Since the Ipatas Administration took over the Enga Provincial Administration in 1997 the volume of lawlessness in the western part of Enga Province increased to some extend in which we feel the effect today.

Over the last 27 solid years under the leadership of Grand Chief Sir Peter Ipatas (GCSPI) the western part of Enga Province went into countless trouble fights. In some sense the governor is not implicated however he has very strong connections in every council ward and communities in both eastern and western part of the Enga Province. Since GCSPI having very strong relationship with the village ward councilors, village leaders, public servants, village court magistrates down to every teachers in high schools, primary schools, community

schools, technical & vocational schools to the least elementary teachers and the list goes on including his diehard supporters. During time of clan fights or major tribe fights he never goes in person to attend to find out what is the main course of the trouble fight. He doesn't have the guards to visit what is the main course of the fight. He enjoys his comfort jones in Iraliya Village which he built as modern Enga using Enga people's money.

From one election year to the other election year he had been using the systematic corruption that is deeply rooted and that gives him election victories depriving rights of choosing a right leader. HRIPA &WEUFA Inc holds no apology in putting the facts together with speaking at the highest voice in respect to the hundreds of people who died as a result of lawlessness in both east and west of Enga Province.

In every villages in the western part of Enga Province you will see more than ten to twenty (10-20) or fifty to one hundred (50-100+) cemeteries subsequent of trouble clan warfare's that occurred during his time as governor of the province. You will see countless widows and orphans in every village (s) both in the eastern and western part of Enga Province dressed in black clothes. If we have a responsible government of Enga Province we would have saved lives and properties worth millions of Kina.

A senseless and careless provincial government who does not care about lives and properties had been reigning through the last 27 solid years through corrupt practices. As a result of a flawed **Systematic Corruption**, people of the western part of Enga Province are calling for a Province Split to have **Opene Province**.

The proposed Opene Province is an idea born out of human blood and lack of government infrastructure services. it's now a serious concern for the people living in the proposed Opene Province. The New Opene Province will be creating tougher by law framework mechanism to eradicate lawlessness affecting the Opene Population.

2. Population

According to the latest available data from National Statistics office shows that the total population of Enga Province in Papua New Guinea is approximately six hundred thousand (600 000) population (people) based on the 2021 National Census and that excludes new born babies and underage kids with a population growth rate of 3% per annum.

National Statistics office figure for Hela Province is estimated to Three Hundred Thousand (300 000) population after split from Southern Highlands Province while Southern Highlands Province remains with an estimated population of more than Five Hundred Thousand (500 000+) plus population in 2011.

Jiwaka Province has another estimated population of less than Three Hundred Thousand (300 000) population after split from Western Highlands Province in 2011. Western Highlands Province remains with an estimated population of almost Four Hundred Fifty Thousand (400 000) people in 2011.

Western Highlands and Enga Province were once run by one administration in 1973-1978 and had the split in the Western Highlands Province and Jiwaka were once shared one provincial administration. East New Britain and West New Britain shared one provincial

administration. Thus our call for Enga Province split is nothing new and it's normal for fast flow for social infrastructure development.


In line with United Nation's Vision 2050 and the 17 Sustainable Development Goal (SDG) program envisioned to develop all communities by socially, politically and economically and it motivates to develop all communities leaving no child behind, both able and disable, creed or color, white or black, Chinese or Indians must travel together towards the United Nation's Vision 2050.

2.1 Population and Background Information

The proposed West Enga Opene Province significantly holds an estimate population of more than three hundred thousand (300 000+) plus population. In reference to the national statistics figure released for Enga Province in 2021 clearly indicates that the proposed West Enga Opene Province has an estimated population of more than three hundred thousand (300,000+) plus population living in;

The statistical Data provided here above and below are flowed confusing figure provided by national statistics office in 2021 however we can use it as an estimate figure.



Such information contributes towards the ignorance of basic government service delivery in Maramuni and other rural areas. Maramuni is part of West Enga and Maramuni will surely be given a district of it's own to run it's own District with it's District Improvement Support (DISP) fund. Maramuni must be given a district by NEC and be affiliated with West Enga Opene Provincial Government.

3. Land Mass & Boundary

The estimated land mass for Enga Province is 8000 Square Kilometers in diameter. The Proposed West Enga Opene Provincial Boundary will be discussed with LLG Presidents, village councilors, community leaders, youth refs, church refs, ngo refs and other interested stakeholders. WEUFA Inc prefers to split following river Lai or Leyaul River down Lai Bridge in Yakanada Village and boundaries may cut through Kamainwan Kaiyap, parts of Ambum District and entire Maramuni District will be another sub district for Proposed West Enga Opone Province.

3.1 Proposed Province & Districts Splits

WEUFA Inc is really committed to split Enga Province to fast track social infrastructure development to reach the unreached population meeting the PNG Government's Twelve (12) MTDG goal plans that links with the UN's Vision 2050 and the seventeen Sustainable Development Goal (17 SDG) Programs.

WEUFA Inc has a longer vision to split Enga Province and this submission is featured to split the six (6) existing districts to fast tract government services to reach the unreached areas and their population.

The six (6) existing districts are;

- 1. Wapinamanda
- 2. Wabag
- 3. Kompiyam Ambum
- 4. Lagaip
- 5. Kandep Porgera
- 6. Porgera

1. Wapinamanda District

Wapinamanda District is proposed to be split as;

- 1.1 Wapinamanda Central & Lower Lai District with two (2) LLG Presidents and
- 1.2 Tsark Minamb District with (2) LLG Presidents each

2. Wabag District

Wabag District is proposed to be split into three (3) districts as;

- 2.1 Wabag Urban or Wabag Central District
- 2.2 Wabag East District and
- 2.3 Wabag West District.

 All will have two LLG Presidents each. The overall view of Wabag

 District has a huge population according to National Statistics Office

 Population Figure in 2021 which is estimated to One Hundred and

Kompiyam Ambum District

Kompiyam Ambum District will be split into two (2) districts as;

3.1 Ambum District and will have two (2) LLG Presidents

Fifty One Thousand Population (151 000).

3.2 Kompiyam District and will have two (2) LLG Presidents Both will have four (4) LLG Presidents. Ambum LLG, Kompiyam LLG, Wale Talu LLG

4. Lagaip District

Lagaip District is proposed to be split into Four Districts for it's highly populated area comprised of more than 150 000;

- 4.1 Lagaip Head Waters District with three (3) LLG's Sambe Tumbiyam LLG, Sambe Wakem LLG and Apuluin LLG
- 4.2 Lagaip Central District with three (3) LLG's Marap Andiuk LLG, Kuwak and Yambu LLG
- 4.3 Sirunki District with two (2) LLG's Sirunki and Tumbiyam LLG

5. Kandep District

Kandep District is proposed to be split into two (2) districts as;

- 5.1 Wage District with Upper Wage LLG, Lower Wage LLG and
- 5.2 Lai Mariyand District proposed with another two (2) LLG's Lai LLG and Mariyand LLG

6. Porgera District

Porgera District is proposed to be split into two (2) Districts with two (2) LLG's each;

- 6.1 Porgera Lower District with Porgera Urban LLG and Lower Porgera LLG
- 6.2 Hewa Paiyala District with two (2) LLG's
 Hewa LLG and
 Paiyala Mt Kare LLG

7. Maramuni District

Maramuni District is proposed with two (2) LLG's each as;

- 7.1 Tumbiyam LLG and
- 7.2 Wakem LLG

4. Inadequate Social Infrastructure Development

In terms of social infrastructure developments. The people living in the western part of Enga Province lack social infrastructure developments. Since the Ipatas Government took over Enga Provincial Administration the people of the western part of Enga Province received less basic government infrastructure services from the Provincial Service Improvement Program Funds (PSIPF). The western part of Enga Province is levelled the least developed part of the Enga Province. We have run down hospitals, schools and no proper road linking our rural population. The Ipatas administration built no proper road from Wabag linking Laiagam, Kandep Wake, Lyumbis Karkar, Porgera, Hewa Paiyala, Net Lyiam, Yaiyam and Maramuni liking the Sepiks. They are still living in darkness since even this country is turning 50 years old,

The so call modern Enga that his supporter's claiming in social media, Facebook and WhatsApp Forums is built in his home village in Iraliya. The world standard technical college, hospital and sealed with permanent 24/7 electricity supply is in Iraliya Village if you compare with such developments in Laiagam, Kandep and Porgera District even though we host the world's largest gold mine.

The east can never be built using the west. The east can never parasite on the west in the pretext of modern Enga. The western part is the host province of giant Porgera Gold mine significantly rated the second largest gold mining in the world producing million more than twenty (20) Million tonnes of gold ounces per year.

Under the United Nation's Vision 2050 and it's core Seventeen (17) Sustainable

Development Goal (SDG) program talks about right to life, right to free education, right to
free health care, right to free road services, right to vote, right to freedom of speech, right to

free electricity, right to clean water, right to sufficient food and right to anything that a human can need in life. Both able and disable no matter what colour or creed whether you white or black, Chinese or Indian. The motor of UN's vision 2050 is to leave no child behind.

The United Nation's Vision 2050 will reach it's check point in the year 2030 and we have only five (5) more years before reaching the check point meaning the UN office will check who is left behind missing out of those that are listed in the seventeen (17) SDG Programs and the Twelve (12) MTP Programs highlighted by the national government.

Since then the West Enga United Front Association (WEUFA) Inc is now calling on the national government to split Enga Province to fast track social infrastructure development meeting all the seventeen (17) SDG Program rights that are listed in the UNDP Program.

Papua New Guinea is a member state of the United Nation's signed its' treaty agreement in 1974 and it's a member state of the common wealth group of countries.

It's very shameful to see unfair service distribution to the western part of the province. The people of the western part of Enga Province deserve a province split to cough up with the other twenty-three (23) provinces in the country.

5. Systematic Corruption & Political Freedom

West Enga United Front Association (WEUFA) Inc is now calling to be politically free from the East Enga Provincial administration and level the Enga provincial administration is corrupted with systematic corruption in terms of government offices are appointed through political influence.

No position in Enga is publically tendered through the government's tender's board. West Enga population demands a complete clean, transparent and accountable administration that is free from such corrupt practices in holding provincial government positions. All provincial government heads must be free from such political interference. All positions must be given based on merits after competency test for two-three years (2-3) or six (6) months to one (1) year competent test.

A vote for public office position had been going on for the last twenty seven (27) years which had crippled the Enga Province's public administrations and the growth rates in provincial revenues are very poor compared to Western Highlands Province and other provinces in Papua New Guinea.

In the geopolitical landscape of Enga Province people think and see Enga Province is growing in economy whereas WEUFA Inc labels that is totally wrong and condemns those that call modern Enga. Where is the modern Enga for Laiagam, Kandep and Porgera? It's really shameful, where is the;

- Hospital built by EPG in West Enga?
- University, Technical College, Tertiary School & Vocational School built by EPG
- Road & bridge infrastructures built by EPG in West Enga?
- Air Strip or an airport built by EPG
- No support for local business man and woman in West Enga
- Only beer licensee to his supporters call kaikaiman promoting lawlessness in West Enga

6. Transit Plan for West Enga Opene Province

The transit plan for West Enga Opene Province come in with the three (3) following option for the Enga Provincial Government and the National Government to peacefully establish Opene Province.

The transit plan give several options of what might transpire or ignite flame to cause economic disturbance activities so prior to bad events the Enga Provincial Government must adopt to option 'A' which gives a violence free option that can bind East and West Enga together as one province except for political reasons.

Transit Plan Option "A"

Option 'A' gives notice to the Enga Provincial Government to adopt the transit plan for Proposed West Enga Opene Province. Option 'A' come in with the following components that can help both the Western Part of Enga Province and the Eastern Part of Enga Province.

Recalling back to the history of Southern Highlands Province and Hela Province, they both agreed on a special understanding and before that. In 2007 when Rt Hon PM James Marape was first voted in to parliament as the member elect for Tari Pori and in his maiden speech, he stood tall and rose up the voice for Hela Province to break away from Southern Highlands Province.

During that time, the National Alliance Party Government lead by Late Grand Chief Sir Michael Thomas Somare as the prime minister went into negotiation for the PNG LNG Project in the Hela Province. During that time PM Marape as an ordinary member of parliament and being the member elect for the host LNG Project, he begged the national government to split Southern Highlands Province and obtain Hela Province.

The national government then advised Southern Highlands Provincial Government to adopt the transit plan for Hela Province. The Southern Highlands Provincial Government then assisted Hela Duna Association (HDA) Inc who was the association responsible in providing logistics and finally came up with the following understanding that helped both Southern Highlands Province and Hela Province.

The both agreed to share the Tari LNG benefit agreement on 60%-40% stakes . The host Province got 60% and the parent province Southern Highlands Province got 40% stake from the Tari LNG Project in 2010.

The transit plan for Opene Province must follow suit. The precedent is set by our Rt Hon Prime Minister James Marepe. In Enga Province we have the Porgera mining agreement still under progress. The Enga Provincial Government must take into consideration that we are calling for a province split is to fast track the social infrastructure developments in the Enga Province.

The breakaway does not mean the western part of Enga Province is cut off from the east whereas we will share many things like;

- 1. Equity Shares from recourse mines
- 2. Government Services
- 3. Language, Culture & Traditions

1. Equity Shares from recourse mines

When it comes to Equity Shares, Enga Provincial Government must respect the West Engan Population's call for province split. The province split call is not just a mere call hence it's featured with fair distribution of stakes from the existing Porgera Gold Mine as well as other upcoming mines in the proposed Opene Province.

2. Government Services

When it comes to government service we will share all government funded infrastructures in both the east and west. The province split call is a friendly call to fast track all government services like roads, bridges, schools, hospitals and other government services to reach the unreached population.

3. Language, Culture & Tradition

Both Opene Province and Enga Province are bound by one unique Enga Language despite minority of people in Porgera, Hewa Paiyal speaks Ipili Language while people living in boarder areas of Western Highlands, Southern Highlands, Hela Province speaks mixture of languages. Someone may ask or have a thought of what language, culture or tradition differentiates Opene Province and Enga Province. We are uniquely bound to be together however due to population increase and social changes, huge land masses, trouble fights and lawlessness we deserve to be split as East Opene Province and West Opene Province.

Enga Provincial Government must respect the host districts' call to split Enga Province and develop special understandings for economic benefits for both East and West Enga Population. The EPG's failure to adopt option 'A' will swift to option 'B' & (C) which are bad for EPG.

WEUFA Inc will soon approach EPG in writing giving a 30 days' notice calling on the EPG to adopt the transit plan. WEUFA Inc will publically circulate the copy of the transit plan. The copy of the transit plan will be given to the National Executive Government. If EPG is cooperative with the transit plan then we will have a appointed governor for Opene Province and if EPG is reluctant to adopt the transit plan "A' option then WEUFA Inc will fall into option 'B'.

Transit Plan Option 'B'

The second option 'B' come in with the following components that is bitter for EPG. WEUFA Inc as the leading organization gives the second option to the EPG if EPG don't cooperate with the option 'A'. WEUFA Inc gives notice that if EPG fails to adopt into option 'A' falls in with the following steps;

- Transit Plan B Notice Paper
- Transit Plan C

• Transit Plan 'B' Notice Paper

WEUFA Inc will move to the national level after the laps of 30days period. WEUFA Inc will be launching it's West Enga Opene Province Transit Plan at the National

Parliament House mid this year 2025 calling on the Marape Roso Government to adopt the transit plan for West Enga Opene Province.

The second option or plan 'B' comes in with the following component which can benefit both the east and west population. Since EPG is reluctant to adopt the transit plan 'A' WEUFA Inc will strike a special deal with the other six (6) district MP's to actively participate in benefits of Porgera Gold Mine and other upcoming mines in the proposed Opene Province. This means that Opene Provincial Government will strike it's friendly deals to develop both East and West Enga Opene Province. This also means that the five percent (5%) stake managed by Mineral Resource Enga will be shift to the six (6) districts in Enga Province evenly.

WEUFA Inc will call for the Enga Provincial Governor to resign and have one of the performing district members of the Eastern part of Enga Province none other than Dr. Tom Lino to act as the governor of the province. If Dr. Tom Lino is reluctant then the NEC will appoint someone to act as the acting governor. This will give way for the EPG to fall back to option 'A' or 'B' in terms of benefit sharing agreement (s) between the two (2) provinces. The acting governor of Enga Province will help adopt and assist in the transit plan for Opene Province and resolves to Terms of Reference Agreement between EPG, Opene Provincial Government and the National Government.

Transit Plan 'C' Forcefully Shut Down Porgera Mine

WEUFA Inc has the plan 'C' option which will be the last option for the people of proposed Opene Province. If EPG and National Government are reluctant to give Opene Province then the WEUFA Inc board of management will officially sign up the resignation papers allowing the people of West Enga will protest against the EPG and the National Government. Expect a full shut down of Porgera Gold Mine Operation. All bridges will be removed, roads will be blocked and many un-necessary things would be done to disturb the Porgera operation.

7. Terms of Reference & Agreement

The Transit Plan comes in with remarkable strategies that bind (s) the parties together. The parties are;

- Opene Provincial Government
- Enga Provincial Government
- National Government
- Witnesses

The parties will develop significant opportunities in terms of recourse benefits for existing Porgera Gold mine and upcoming mines including other form of economic development activities in both Opene Province and Enga Province.

This TOR or MOA also gives an option for share splits from Porgera Gold Mine and income revenues from Enga Children's Trust Fund and other Enga Provincial Government's Assets that are secured using Enga Peoples money.

EPG is now facing social catastrophic challenge ever in the history of Enga Province. WEUFA Inc give challenges for the benefits of both east and the west population. EPG has to embrace it and adopt the transit plan. Reluctant to do so may result to un-necessary violence. This is the voice of the Opene People who inherited the Hela blood.

8. Opene Provincial Government Physical Cooperate Plan

West Enga Opene Provincial Government has a five-ten (5-10) years cooperate plan that comprises of the physical structures of the New West Enga Opene Province. The main objective of the Physical Plan outlines how to eradicate lawlessness in both West Enga Opene Province and East Enga Opene Province to create a conducive and peaceful environment for her citizen.

Our second most important strategic plan we construct is to open up government services to reach the unreached population in terms of building road infrastructures, building schools, hospitals, airstrips and other government services.

The third most important strategic plan we create is to open up business activities in terms of opening up local business opportunities to put money into people's pocket.

The West Enga Opene Provincial Government's Physical Cooperate Plan gives in detail of the new outlook of the New West Enga Opene Province.

Recommendation

1. Satellite

State Government must purchase the satellite and boost up the digital security system that can monitor every individual. Our freedom of movement is now confined, we are not free. All citizens need freedom of movement. The use of satellite is of more importance to confiscate those who are in position of illegal firearms. The satellite would be a value to our efficient form of communication.

2. Capital Punishment

Capital Punishment must be imposed as a bill in the national parliament. Hard core criminals, murders, rapist and drug traffickers' must be executed. They deserve to die.

3. Enga Province Split

Enga Province must be split because of huge population and land mass. It needs a split to have two (2) governors. We the people of West Enga are now calling Marape Roso Government to split Enga Province and give us Opene Province and that is our third recommendation by Human Rights Inter-Pacific Association (HRIPA) Inc in support of West Enga United Front Association (WEUFA) Inc
